Safety for Women: Monitoring Batterers' Programs

It is imperative for batterers' counseling and educational programs to recognize that there are risks to the safety of battered women and encourage battered women to undertake safety planning when their partners become participants in a batterers' intervention program. The primary goals of batterers' programs must be to end violence and promote the safety of battered women and their children.

The Safety for Women manual examines safety strategies for battered women whose partners are in batterers' treatment groups. This manual suggests that when batterers are referred to treatment programs, advocates and battered women should monitor those programs to assure that they are effective and that they do not endanger battered women. Critical issues in the counseling of batterers are explored, as are legal questions relating to the confidentiality of batterer communications in treatment programs.
